About the LNS

The Luxembourg National Health Laboratory, "Laboratoire national de santé" (LNS) is a public institution operating under the supervision of the Ministry of Health in Luxembourg. It is organized as a multidisciplinary institute, which along with an administrative department, includes six scientific departments related to the fields of morphological and molecular pathology, genetics, medical biology, microbiology, forensic medicine and health protection.

The LNS has new premises with modern, top-notch infrastructure to respond to the requirements and most recent developments in medical and analytical sciences. The purpose of the LNS is to develop analytical and scientific expertise related to the prevention, diagnosis and monitoring of human diseases; to ensure the role of a national control and reference laboratory and to provide medico-legal services.

- Documentation of toxicological findings
- · Participate in teaching and training activities
- Collaborate on research projects in the field of forensic toxicology
- Attend court of law as expert witness
- Active participation in the accreditation process of the laboratory
